## **8.205 MEDICAID STATEWIDE MANAGED CARE SYSTEM**

### **8.205.9.B [Required Services]**

The following are required services of the statewide system of community behavioral health care:

#### **8.205.9.B.3 Targeted Case Management –**

Case management services furnished to assist individuals, eligible under the State Plan, in gaining access to needed medical, social, educational and other services.

## **8.205.9.B.8**

### **Alternative behavioral health services—**

Administration of non-traditional, community-based services not available through the State Plan but authorized through the Department's 1915(b) waiver with the Centers for Medicare and Medicaid Services.

- **8.205.9.B.8.c**

#### **Intensive Case Management --**

- **Community-based services averaging more than one hour per week, provided to adults with serious behavioral health disorders who are at risk of a more intensive 24 hour placement and who need extra support to live in the community.**
- **Services are assessment, care plan development, multi-system referrals, assistance with wraparound and supportive living services, monitoring and follow-up.**
- **Intensive case management may be provided to children/youth under the Early Periodic Screening, Diagnosis, and Treatment (EPSDT) program.**
